Notice Regarding Transition to a Company with an Audit and Supervisory Committee and Changes to Executive Personnel

Hanwa Co., Ltd. ("Hanwa") decided, at the Board of Directors meeting held today, to transition from a company with a Board of Auditors to a company with an Audit and Supervisory Committee, subject to approval at Hanwa's 78th Ordinary General Shareholders Meeting to be held on June 26, 2025, with the aim of further strengthening corporate governance.

In line with this, Hanwa also decided today on the following candidates for Directors to be submitted to the 78th Ordinary General Shareholders Meeting:

1. Transition to a Company with an Audit and Supervisory Committee

(1) Purpose of the transition

The aim is to strengthen the supervisory function of the Board of Directors and further enhance corporate governance by making Audit and Supervisory Committee Members, who are responsible for auditing the execution of duties by Directors, members of the Board of Directors.

(2) Timing of the transition

If the necessary amendments to the Articles of Incorporation are approved as proposed at Hanwa's 78th Ordinary General Shareholders Meeting to be held on June 26, 2025, Hanwa plans to transition to a company with an Audit and Supervisory Committee on the same date.
