Announcement Regarding the Acquisition of Marui Holdings Co., Ltd. and Marui Sato Kaisan Co., Ltd. as Group Companies

Hanwa Co., Ltd. (hereinafter “HANWA”) hereby announces that it has acquired all shares of Marui Holdings Co., Ltd. and, effective February 17, 2026, has welcomed the company and its subsidiary, Marui Sato Kaisan Co., Ltd. (hereinafter “Marui Sato Kaisan”), into the Hanwa Group.

Marui Sato Kaisan is a marine products processing company based in Betsukai-cho, Notsuke-gun, Hokkaido. The company primarily processes and sells seafood landed in eastern Hokkaido, including scallops, salmon, herring, flatfish and so on. In particular, the scallop harvested in the Notsuke district of eastern Hokkaido are highly acclaimed in the market for their large size and thickness of meat. They are popular not only in Japan but also overseas, and Marui Sato Kaisan leverages its strengths as a producer-based manufacturer in its business operations.

By bringing Marui Sato Kaisan into the Group, HANWA aims to further enhance its presence in the scallop market, alongside Marugo Fukuyama Suisan Co., Ltd. (City of Wakkanai, Hokkaido), which joined the Group in September 2024. In addition, HANWA will strengthen its product appeal and supply system by collaborating with its other processing subsidiaries, including Hanwa Foods Co., Ltd., East Japan Foods Co., Ltd., and Maruhon Honma Suisan Co., Ltd. Based on these foundations, HANWA will take charge of sales to overseas markets such as North America and ASEAN, aiming to maximize growth and synergy across its entire Hanwa Food Department.
